Blue Heron Specialty Products, LLC, shall not be liable for typographical errors.

This warranty is applicable provided such products are used under normal conditions within the recognized pressure, flow and temperature limits and are given normal service and care. This warranty is applicable only to products purchased from Blue Heron Specialty Products, LLC. If said returned product is found by Blue Heron Specialty Products, LLC to be defective in workmanship or materials, it shall be repaired or replaced without charge, pursuant to the terms of this warranty. Any claims with respect to such equipment must be made to Blue Heron Specialty Products, LLC thereof in accordance with the terms of the warranty.
